### Industry & Fund Update

#### Aditya Birla Sun Life launches Crisil IBX Gilt June 2027 Index Fund

Aditya Birla Sun Life Mutual Fund has launched Aditya Birla Sun Life Crisil IBX Gilt June 2027 Index Fund, an open-ended Target Maturity Index Fund tracking the CRISIL IBX Gilt Index - June 2027 with a moderate interest rate risk and relatively low credit risk. The new fund offer or NFO of the scheme is currently open for subscription and will close on June 4. The scheme will reopen for continuous sale and repurchase within five business days from the date of allotment. The investment objective of the scheme is to generate returns corresponding to the total returns of the securities as represented by the CRISIL IBX Gilt Index - June 2027 before expenses, subject to tracking errors. In line with the maturity profile of the underlying index, the maturity of the scheme will be June 30, 2027. The scheme will offer regular and direct plans with growth and IDCW options. The minimum amount of investment, additional purchase, and repurchase is Rs 1,000 and in multiples of Re 1 thereafter. The scheme will be benchmarked against CRISIL IBX Gilt Index - June 2027. Bhupesh Bameta and Sanjay Godambe are the managers of the scheme. This fund will invest 95-100% in instruments forming part of the CRISIL IBX Gilt Index - June 2027 and 0-5% in debt/money market instruments, cash and cash equivalent.

#### Kotak Mutual Fund launches Nifty 100 Low Volatility 30 Index Fund

Kotak Mutual Fund has announced the launch of the Kotak Nifty 100 Low Volatility 30 Index Fund, an open-ended scheme replicating or tracking the Nifty 100 Low Volatility 30 Index. The new fund offer or NFO of the scheme will open for subscription on May 22 and close on May 31. The scheme will reopen for continuous sale and repurchase on or before June 12. It will be benchmarked against NIFTY 100 Low Volatility 30 Index (Total Return Index). The scheme will be managed by Devender Singhal and Satish Dondapati (equity investments), and Abhishek Bisen (debt investments). The Nifty 100 Low Volatility 30 Index is a strategic investment index comprising stocks of large market capitalisation, selected from the Nifty 100 Index. Focus on low-volatility stocks within the Nifty 100 Index ensures an investment portfolio. The selection of securities and their weights are based on volatility for the last year. It offers a cost-effective and transparent approach to investing in the Indian stock market within the largecap space, according to a press release by the fund house. The investment strategy would revolve around reducing the tracking error through rebalancing of the portfolio, taking into account the change in weights of stocks in the index as well as the incremental collections/redemptions from the Scheme.

#### SBI Mutual Fund launches SBI Automotive Opportunities Fund

SBI Mutual Fund has announced the launch of the SBI Automotive Opportunities Fund, an open-ended equity scheme following the automotive and allied business activities theme. The new fund offer or NFO of the scheme will open for subscription on May 17 and it will close on May 31. The investment objective would be to generate long-term capital appreciation to unit holders from a portfolio that is invested in equity and equity-related instruments of companies engaged in automotive and allied business activities theme from the domestic as well as global universe. The fund will be benchmarked against Nifty Auto TRI. The scheme will be managed by Tanmaya Desai and Pradeep Kesavan. The fund will invest 80%-100% in equity and equity-related instruments of companies engaged in automotive and allied business activities theme (including equity derivatives), 0 - 20% in equity and equity-related instruments of companies other than engaged in automotive and allied business activities theme (including equity derivatives), 0 - 20% in debt and debt-related instruments (including securitized debt {upto 20%} & debt derivatives) and money market instruments including tri-party repos, 0 - 10% in units issued by REITs and InvITs, with the exposure in line with SEBI limits specified from time to time.

#### SBI Mutual Fund and Zerodha Mutual Fund files draft documents with Sebi

SBI Mutual Fund and Zerodha Mutual Fund have filed draft documents with Sebi for a quant fund and a fund of fund investing overseas, respectively. SBI Quant Fund- It will be an open-ended equity scheme following Quant based investing theme. The investment objective of the scheme will be to generate long-term capital appreciation by investing in equity and equity-related instruments selected based on a quant model theme. The minimum application amount will be Rs 5,000 and in multiples of Re 1 thereafter. The quant fund will be benchmarked against Nifty 200 - TRI. The scheme will be managed by Sukanya Ghosh and Pradeep Kesavan. The scheme will invest 80-100% in equity and equity-related instruments selected based on a quantitative model, 0-20% in other equity and equity-related instruments, 0-20% in debt securities (including securitized debt and debt derivatives) and money market instruments (including the Tri Party Repo), and 0-10% in units issued by REITs and InvITs. Zerodha Equity and Gold FoF- It will be an open-ended fund-of-funds scheme investing in the units of Equity ETFs/Index Funds and Gold ETFs. The investment objective of the scheme will be to balance risk and reward through diversification across asset classes and

generate better risk-adjusted returns predominantly through investment in equity ETFs/ index funds and gold ETFs. The scheme will be benchmarked against 70% Nifty 200 (TRI) + 30% Domestic Price of Physical Gold and will be managed by Kedarnath Mirajkar. The scheme will invest 95-100% in units of equity ETFs/ Index Funds and Gold ETFs, 0-5% in debt and money market instruments, and cash and cash equivalents.

#### LIC Mutual Fund changes exit load for four equity schemes

LIC Mutual Fund has announced a change in the exit load structure of its four equity and equity-oriented schemes. The fund house informed about this change to its unitholders through a notice-cum-addendum. The changes will be effective from May 27. The duration of 12 months considered earlier is now changed to three months.


