Industry & Fund Update

SBI Mutual Fund launches SBI Automotive Opportunities Fund

SBI Mutual Fund has announced the launch of the SBI Automotive Opportunities Fund, an open-ended equity scheme following the automotive and allied business activities theme. The new fund offer or NFO of the scheme will open for subscription on May 17 and it will close on May 31. The investment objective would be to generate long-term capital appreciation to unit holders from a portfolio that is invested in equity and equity-related instruments of companies engaged in automotive and allied business activities theme from the domestic as well as global universe. The fund will be benchmarked against Nifty Auto TRI. The scheme will be managed by Tanmaya Desai and Pradeep Kesavan. The fund will invest 80%-100% in equity and equity-related instruments of companies engaged in automotive and allied business activities theme (including equity derivatives), 0 - 20% in equity and equity-related instruments of companies other than engaged in automotive and allied business activities theme (including equity derivatives), 0 - 20% in debt and debt-related instruments (including securitized debt {upto 20%} & debt derivatives) and money market instruments including tri-party repos, 0 - 10% in units issued by REITs and InvITs, with the exposure in line with SEBI limits specified from time to time.

Samco Mutual Fund launches Special Opportunities Fund

SAMCO Mutual Fund has announced the launch of the Special Opportunities Fund. Samco Special Opportunities Fund is an open-ended equity scheme following a special situations theme. The new fund offer or NFO of the scheme will open for subscription on May 17 and will close on May 31. The fund is designed to capitalise on identifying the market opportunities, aiming for long-term capital growth through undervalued or overlooked opportunities, according to a press release by the fund house. The scheme will be benchmarked against Nifty 500 - TRI. The scheme will be managed by Umeshkumar Mehta, Paras Matalia, and Dhawal G. Dhanani. No exit load will be charged if investments is redeemed or switched out after 365 days from the date of allotment of units.

Franklin Templeton Mutual Fund files draft document with Sebi for a multicap fund

Franklin Templeton Mutual Fund has filed a draft document with Sebi for a multicap fund. Franklin India Multicap Fund will be an open-ended scheme investing across largecap, midcap and smallcap stocks. The scheme aims to generate long-term capital appreciation by investing in a portfolio of equity and equity-related securities of largecap, midcap and smallcap companies. The scheme will be benchmarked against the Nifty 500 MultiCap 50:25:25 Total Returns Index. R. Janakiraman and Sandeep Manam will be the managers of this fund. The scheme will offer regular and direct plans with growth and IDCW options. The minimum amount of subscription for fresh purchase will be Rs 5,000. For additional purchase, the minimum amount will be Rs 1,000. For Systematic Investment Plan (SIP), the minimum amount required will be Rs 500. The minimum amount for redemption will be Rs 1,000. The amount for subscription, SIP and redemption in excess of the minimum amount specified above will be any amount in multiple of Re 1. In respect of each purchase of units, an exit load of 1% will be applicable if the units are redeemed/switched-out within one year of allotment. The scheme will invest 75-100% in equity and equity-related securities of largecap, midcap and small cap companies, 0-25% in debt and money market instruments, cash and cash equivalent, and 0-10% in units issued by REITs and InvITs.

SBI Mutual Fund files draft with Sebi for innovative opportunities fund

SBI Mutual Fund has filed a draft document with Sebi for an innovative opportunities fund. SBI Innovative Opportunities Fund will be an open-ended equity scheme following the innovation theme. The investment objective of the scheme is to provide

investors with opportunities for long-term capital appreciation by investing in equity and equity-related instruments of companies that seek to benefit from the adoption of innovative strategies and themes. The scheme will be benchmarked against Nifty 500 TRI. It will be managed by Dinesh Balachandran and Pradeep Kesavan. The scheme will offer regular and direct plans both with growth and IDCW options. An exit load of 1% of the applicable NAV will be there if units purchased or switched in from another scheme of the fund are redeemed or switched out on or before 1 year from the date of allotment. The exit load will be nil if units purchased or switched in from another scheme of the fund are redeemed or switched out after 1 year from the date of allotment. SBI Innovative Opportunities Fund will invest 80-100% in equity and equity-related instruments of companies that seek to benefit from the adoption of innovative strategies and themes (including equity derivatives), 0-20% in other equity and equity-related instruments (including equity derivatives), 0-20% in debt securities (including securitised debt and debt derivatives) and money market instruments including tri-party repos, and 0-10% in units issued by REITs and InvITs. The minimum application amount will be Rs 5,000 and in multiples of Re 1 thereafter. The minimum amount for additional purchase will be Rs 1,000 and in multiples of Re1 thereafter. The minimum redemption amount is Rs 500 or 1 unit or account balance whichever is lower.

Tata Mutual Fund merges banking & PSU debt fund with corporate bond fund

Tata Mutual Fund has announced the merger of Tata Banking & PSU Debt Fund with Tata Corporate Bond Fund. The two schemes will be merged and Tata Corporate Bond Fund will be the surviving scheme. The fund house informed about this to its unit holders through a notice-cum-addendum. The merger will be effective from June 15. From this date, Tata Banking & PSU Debt Fund will cease to exist and the unitholders of the scheme will become unitholders of Tata Corporate Bond Fund. The fund house mentioned that the exit option of 30 days, at prevailing NAV, without exit load will be given to the unitholders of merging scheme i.e. Tata Banking & PSU Debt Fund and to the unitholders of Tata Corporate Bond Fund (i.e. surviving scheme).
