



# Recovery in Greenback


Dollar index can witness further decline towards 94-93.5 levels as any decline in greenback is bullish for Crude oil.

### US Production have started to ease

U.S. oil output has begun to ease after six years of sharp increases. Energy Information Administration data shows U.S. crude and condensate production peaked at 9.612 million barrels per day (bpd) in April and had declined by 316,000 bpd by June.

# Fall in latest rig count data

Last week, Baker Hughes published its US crude oil rig count report on September 11, 2015. The data showed that US crude oil rigs fell by ten to 652 for the week ending September 11, 2015. Likewise, the crude oil rig count fell by 13 to 662 for the week ending September 4, 2015. The active US crude oil rig count fell for the second consecutive week in the last eight.
